Message from the CEO

This past year has seen CMMC return to some sense of normalcy following the end of the pandemic. Patient volumes returned to more historical levels and our team members welcomed the opportunity to serve a healthier community.

CMMC was honored to be recognized as a 2023 Top 100 Critical Access Hospital by the Chartis Center for Rural Health. This annual recognition program is acknowledged as the most comprehensive and objective assessment of a rural hospitals performance and looks at various publicly

available measures across a rural hospital's operations, including quality, safety, and financial performance.

CMMC was also one of only eight hospitals in Montana to receive the CMS 5-star Overall Hospital Quality rating. The 5-star rating is the highest designation available for hospitals from the Centers for Medicare and Medicaid Services. These types of recognition are only made possible by the tireless efforts of the staff here at CMMC. Their dedication to providing quality health care services to all Central Montana continually amazes me.

This past year also saw CMMC make great strides towards bringing a comprehensive Cancer Center to central Montana. The community support for this project has exceeded all expectations and we look forward to having this life changing service available by late 2024 or early 2025.

Central Montana Medical Center completed another fiscal year as of June 30th. During this past fiscal year, CMMC endured numerous challenges including decreases in reimbursement from Medicare, Medicaid and some Commercial Payers, continued escalation of drug expenses, medical technology, medical supplies, building costs, and shortages of permanent staff. All impacts created new financial and operational challenges and dramatic cost increases.

Despite these challenges, the hospital was able to invest in a new MRI, a phone system upgrade, a redesign of our Sterile Processing Department, including new, state-of-art equipment, and various other equipment upgrades, that will help us support the services we provide to the community. The hospital was able to make many of these investments due to federal Provider Relief Funds (PRF) and due to the generous support of the CMMC Foundation. Although CMMC had continued obstacles this past fiscal year, financially we ended with a positive bottom line. Success in healthcare is primarily measured in the quality of care provided, however, it is important to maintain a strong financial performance to support future investments back into the care we deliver. We continue to explore new services, and if feasible, bring those services to the community.

For the Fiscal Year Ending June 30, 2023, the total unrestricted net revenue was \$49,278,004. Total operating expenses were \$48,212,152. Unreimbursed and unfunded contractual revenue write-offs from Medicare, Medicaid, and all other Third-Party Payers along with charity care and bad debt write offs, accounted for total Revenue Deductions or reductions of \$41,812,734, or 48.1% of gross Patient Service Revenue. This year's operations produced a positive net operating income for the Fiscal Year of \$1,065,852, which was better than the budget for FY2023. Non-Operating Income was primarily driven by a Helmsley Foundation Grant Funding Pledge of \$3,000,000, Employee Retention Tax Credit of \$1,833,873, and Charitable Donations from the Community for the Cancer Center of \$1,267,101. The remaining amount of Non-Operating income was due to investment income. This all resulted in a positive overall net

income of \$7,398,586.

YOUR CANCER CENTER GIFT HAS MORE IMPACT THAN ONE MIGHT REALIZE.

While working on the Cancer Center Campaign, Amy d'Autremont, CMMC Oncology Nurse Navigator has been vital in helping understand the "WHY's" of bringing a Cancer Center to Central Montana. While many of these reasons are more evident and measurable, she has given light on one that is a bit more surprising, and emotional.

Amy shares that sadly we have residents of Central Montana who forgo cancer treatment due to the obstacles of traveling out of town for care. "A cancer diagnosis in itself is overwhelming. And then to bring in the logistical conversation of traveling out of town for treatment, time off work, time away from family and friends- this can push individuals to lose their ability to cope. When coping loss occurs, the emotional roller coaster takes hold and people shut down."

Amy explains that part of her position as Oncology Nurse Navigator is to help navigate these overwhelming pieces for patients and their families and is quick to give much credit to community organizations such as Tough Enough to Wear Pink and others who provide important resources of support to cancer patients. However, Amy shares, "even with that support, treatable cancer patients do make the treatments and it breaks my heart."

Bridgett Johnson, Lewistown resident and past Lewistown Library Director, is a cancer patient who, if Lewistown did not offer infusion services shares, she would be in the group that would consider foregoing treatment. Bridget is a diagnosed treatable terminally ill cancer patient who

says, "I give credit to CMMC for having infusion care, but it is not enough, we also need radiation and medical oncology. We must give everyone, no matter their treatment plan, the option to be in town for their care. For me to travel out of town for infusion care would be at minimum \$500 each month. If I had to choose, I would seriously have to consider declining treatments as I feel I could not justify that burden on my family."

Amy d'Autremont expresses, "Having a Cancer Center at Central Montana Medical Center would eliminate patients from having to weigh out this decision, it would give them a familiar space to receive care! To bring this to Central Montana is truly bringing HOPE CLOSE TO HOME."

Amy gives thanks to all of those who have already given and urges others to give a gift that is meaningful to them. "Each of us together will make this a reality. We as a cancer team are here for you today and hope to bring more support and services tomorrow."

FUND REPORT

The Medical Center Foundation is under the investment umbrella of Central Montana Foundation and together share the Roundup newsletter.

June 30, 2023, ended the year with a balance of just over \$3.1 million dollars in a combined 16 funds; 4 less funds than the previous year. The lesser of four funds is due to Ambulance and Emergency Room Funds being combined, and three non-active/completed project funds being closed out. These include: 3D Mammography Fund, Intensive Care Unit Fund, and Indirect Costs Fund.

CMMC is proud and grateful that the Cancer Center fund ended FY 2023 with a balance of \$1.2 million and a secured total of \$2 million in funds gifted or pledged. Each gift, no matter the size, is important. Much appreciation to each donor, volunteer, and leader involved.

During FY 2023, \$143,632 was gifted through grants from the Medical Center Foundation to CMMC services and community organizations including a \$41,000 gift to purchase a new Dexa Scanner and a \$40,000 gift toward the purchase of two new Hospice vehicles.

Sincere thank you to the many people who think of the Foundation with your annual giving, memorials, and estate gifts.

(100) CRITICAL ACCESS TOP HOSPITAL 2023 CHARTIS Central Montana Medical Center was recognized as a Top 100 Critical Access Hospital by The Chartis Center for Rural Health. This annual recognition program honors outstanding performance among the nation's rural hospitals based on the results of the Chartis Rural Hospital Performance INDEX™. Across the nation, the top 100 rural providers continue to serve as a source of inspiration for hospital leadership teams and staff working diligently every day to improve the delivery of care within their local communities.

CMMC was awarded CMS 5-star Overall Hospital Quality Star Rating. The 5-star rating is the highest designation available for hospitals from the Centers for Medicare and Medicaid Services.

The CMS star system is based on weighted quality scores in mortality, safety of care, readmission, patient experience, and timely and effective care.

CMS awarded the 5-star rating to 483 hospitals, 8 of which were in Montana.

Rich and Donna have chosen to support this program in memory of their daughter Darcy Dengel, RN, who lost her life in a medflight accident in 2007.

Her dedication to rural...the criticality of needing these positions in rural Montana. Exposing these kids to healthcare & medicine is a great opportunity to grow our own for many healthcare professions, and Dr. LePage knows this all too well.

Bringing a Cancer Center to Central Montana became a possibility when The Leona M. and Harry B. Helmsley Charitable Trust chose CMMC as a strategic partner and pledged \$9 million for the project. Further action over the last two years has resulted in \$3.6 million dollars in funds raised from a community campaign and another \$2 million has been committed by the Central Montana Medical Center through debt financing. The project is estimated to be a \$15.6-18.9 million dollar project – so while we have come so far, work is still to be done.

Statistically speaking it is not hard to understand why a Cancer Center is important to have located in Central Montana. Currently our friends, family, and neighbors of Central Montana are traveling an estimated 165,000 miles annually to receive oncology care. While CMMC has established an infusion center, located in the previous Intensive Care Unit, folks still travel for radiology appointments and medical oncology. When one in 3 of us are expected to be diagnosed with cancer in our lifetime, it is evident that comprehensive cancer care would be a worthwhile investment in our community. NEW MRI MACHINE

The hospital's new scanner, a Siemens MAGNETOM Altea 1.5T, arrived last year and has been in use since Dec. 20. According to Geri Rector, Radiology Supervisor at CMMC, the new MRI machine is a noticeable upgrade over the hospital's previous MRI equipment. "It has faster scan times and is quieter," Rector said. "It also gives better image quality, which makes it easier for the radiologist to read." The new scanner is also roomier for patients than the old one, and Rector said patients have noticed the difference.



"Patients who have been in both machines say it's more comfortable," she said. "The music and sound during the scan has improved a lot as well. People can actually hear it over the machine now."

Taken together, these features allow for faster, more precise results from magnetic resonance imaging, which uses magnets to produce detailed 3-D anatomical images to detect and diagnose diseases or injuries and monitor treatment.

The CMMC Foundation contributed \$500,000 toward the new MRI machine to help defray some of the cost.

"The mission of the Medical Center Foundation is to support the health services, programs, and practitioners of Central Montana," said Foundation Director Abby Franks. "With the MRI Machine at CMMC having more than 1,000 uses each year, and those uses providing a direct correlation to helping in the health and treatment of our community members, the Foundation is proud to have utilized donated funds to make this project a reality."

"We're up to date compared to the big hospitals in the state," she said. "We're on the same or better platform."

Auxiliary

The Auxiliary is designed to support CMMC by raising funds that will benefit the different departments through the purchase of needed equipment and supplies. Each year, they receive requests for items that will enhance the services that the hospital provides.

This year 5 different requests were granted for a total of \$7,009.00. These funds were raised through gift shop sales, holiday bazaars and our annual parking lot rummage sale. Volunteers man the gift shop, bake goods for the bazaars and organize the rummage sale.

The Auxiliary is also making and filling the chemo bags to give to infusion patients, afghans to veterans who end up in the hospital, and giving scholarships, among many other projects.

The auxiliary has 75 members and meets monthly on the second Monday of every month. Many hands make light work so if you know anyone who has a heart of service, check out the CMMC auxiliary! It's only \$5.00 a year to become part of an amazing group that is striving to help in any way that they can.
