Betti Foundation provides large endowment for Winnett youth

(Editor's Note: The following article was written by Leslie Iverson of the Petroleum County Community Center announcing a \$1.6 million gift for a youth program from the Betti Foundation. The Betti Foundation set up a permanent endowment with Central Montana Foundation to receive the gift.)

The Petroleum County Community Center (PCCC) is honored to announce that the Bruno and Evelyne Betti Foundation of Lacey, WA has recently gifted \$1.6 million to fund the Bruno and Evelyne Hill Betti Foundation Youth Program in Winnett, MT. This gift provides for startup funding and an endowment for long-term sustainability.

The Winnett community, through this gift, will carry on the Bettis' tradition of ensuring that underserved youth have access to a safe place for structured enrichment programs. The youth program will commence this fall and will be held at the First Baptist Church for the first year. Once construction is complete in the summer of 2022, the program will move to the new PCCC building. Evelyne and Bruno Betti were champions of many deserving programs over the years, but youth programs were always at the heart of their philanthropic gifts.

Evelyne Hill was raised on a cattle and sheep ranch and attended her early years of education in a schoolhouse made of cottonwood logs in the Lodge Pole Creek area northwest of Sand Springs, MT. Evelyne attended and later graduated from Winnett High School in 1936. She loved her small

town and never forgot the community from which she came. Later in life, after business success, Evelyne and Bruno gave back to the Winnett community a number of times over the years. The Petroleum County Library, Petroleum County Ambulance, and the Winnett Cemetery have been recipients of the generosity of the Bruno and Evelyne Betti Foundation.

Evelyne left Montana to seek a life in Seattle, where she attended barber college and became an accomplished hairdresser. Her skill as a hairdresser paid for two years at the University of Washington to study design and home economics. Evelyne met Bruno Betti at a Sadie Hawkins dance and subsequently they married in May of 1941. Bruno Dante Betti, the son of Italian immigrants, was born

and raised in the Black Diamond and Saint George Area of Seattle. Bruno worked in the foundry at the Seattle shipyards during and after World War II.

Bruno and Evelyne started their own business with the purchase of a Christmas tree farm on 440 acres in the Hawks Prairie area of Lacey, WA and was later followed by a pig-raising operation and a commercial slaughterhouse. Entrepreneurial in nature, they then began building warehouses for new businesses, offering their tenants attractive rents, and therein began the legacy of their generosity and giving back to their community.

Following Bruno's passing in 1998, Evelyne expanded the warehouse complex, and the Hill-Betti Business Park was developed. Evelyne's deep sense of community was evident in her involvement with various groups and her long-term support of organizations like the Boys and Girls Club of Lacey, WA, and vocational and technical trades of South Puget Sound Community College. She supported scholarship programs in "practical degrees" such as engineering, business, nursing, science, and teaching through Saint Martin's University. In 2006, the South Sound Partners for Philanthropy named Evelyne "Individual of the Year" for her charitable work throughout the community. After her passing in 2007, the Bettis' estate was used to form the foundation that was to continue their philanthropic missions.

Evelyne's fighting spirit was nurtured in the Musselshell Breaks among scattered, timbered buttes along Lodge Pole Creek, while trying to hold her own against five brothers. The ruggedness of the time and isolation of her upbringing surely laid the groundwork for whom she later became. A young girl, riding her saddle horse "Old Darkie," surely needed a leg up on occasion. Evelyne would have received that leg

Between the concert, donations, grants and other fund-raisers, \$578,000 was raised for the 3D Mammo and Breast Biopsy Guidance System Capital Campaign. "There have been 1,306 total mammograms done since the acquisition of the equipment last June, and 21 positive breast cancers - all detected early thanks to the 3D equipment," Ann said. ❖

CMF Manager Ann Tuss reflects on 36-year career at CMMC

Ann was just 21 years old when she went to work at Central Montana Medical Center (CMMC) in the social services department. She worked there 10 years before transitioning into community relations, then the Medical Center Foundation (MCF) - a position that led to many friendships through the years with donors, her advisory board members and colleagues. All who have the privilege of knowing Ann are saddened that she will retire later this summer after a 36-year career at CMMC.

Much has changed during her tenure. Ann Butenhoff married her high school sweetheart, Brett Tuss, a year or so after she went to work at CMMC and has been his best hand on the couple's ranch on the Divide. Together they raised three children and are now enjoying being grandparents to 3-year-old Mathilda and 5-month-old Meredith Peila.

Ann feels great satisfaction regarding the work she did at MCF; knowing that fund-raising for medical equipment, training, building projects and other healthcare needs has literally helped save lives. "I'm so humbled about the donors that I met and continue to have friendships with all these years," Ann said. "They have helped me grow both personally

and professionally, and the fact that they have been so loyal to MCF and what we do means a great deal to me."

Ann works closely with MCF Advisory Board members and praised them for investing of their time and financial resources to improving healthcare. "They're not afraid to dive into a project they believe in. Before we ask donors for a dime, we already know that we will be successful."

Working with donors to establish new funds has also been important work for Ann. Especially meaningful are the Friends of 1st Responders that helps with program and training needs; Darci's Gift: To Save a Life, which provides CPR classes to local students; and the HOPE fund, which provides financial assistance for CMMC employees in crisis.

Ann said she will miss her CMMC colleagues who have become her very good friends. Another highlight for Ann has been the relationship between Central Montana Foundation and MCF. "Our two foundations have a unique relationship that benefits both of us," she said.

CMF awards \$100,000 in major grants at Annual Meeting

Central Montana Foundation (CMF) held its annual meeting and luncheon May 25 with crowd of nearly 90 people in attendance.

Before the board of directors left the Elk's Clubhouse, they had awarded \$100,000 in major grants (\$5,000+) to eight local organizations. A portion of earnings from the Mildred Bryte endowment is used to fund major grant requests of \$5,000 or more at the annual meeting. This year's successful major grant recipients include:

• **Central Montana Medical Center-Surgical Service, \$25,000:** CMMC received funding to help purchase a Stryker Power System 8 Sagital Saw. CMMC Surgical Services Manager Lisa Ash said the instrument will be used in orthopedic and podiatry surgical procedures.

• **Cheadle Volunteer Fire Department, \$10,000:** The grant will help cover the construction expenses to add an addition to the existing fire hall where they can keep fire fighting vehicles ready to go year-round. Cheadle has 275,000 acres in its district, according to Cheadle Volunteer Fire Department Bill Stahl.

• **Denton Ambulance Service, \$15,000:** The grant will help Denton Ambulance Service with the purchase of a new all-wheel drive ambulance and medical equipment. Denton Lion's Club is assisting with the fund-raising for this project and both Larry Rice and Carla Allen (also an EMT on the Denton Ambulance), expressed the dire need to replace the 23-year-old ambulance currently in service.

• **Judith Basin Historical Society, \$15,000:** Funds were awarded to help with expenses of the roof replacement of the Basin Trading Post Mercantile in Stanford, which is owned by the non-profit, Judith Basin Historical Society. Tess Brady said the roof is leaking and the patching they've done to get by isn't enough.

• **Lewistown Art Center, \$5,000:** The grant will be used for the ceramic studio upgrade. Lewistown Art Center Director Mary Callahan Baumstark said the Ken Edwards Memorial Clay Studio is in need of an update, including electrical and supplies.

• **Lewistown Ice Skating Association, \$10,000:** Funds were granted towards the dasher board project at the Lewistown Ice Skating Rink. Scott Kirsch said the dasher boards they have been using were purchased used in 2009 and are falling apart. The dasher boards are part of an overall improvement project including building new player benches, scorekeepers box and penalty boxes, concrete work, and new locker rooms.

• **Stanford Open, \$10,000:** CMF awarded funds to this non-profit which is taking on a large scale improvement project for the Judith Basin County Fairgrounds. The grant from CMF will be used for a bronze structure at the fairgrounds entrance and be a kick off to the larger project to include new bleachers, crow's nest, chutes, pens and arena. Ollie Urick said the fairgrounds is the only public venue for activities in the county and important to the community.

• **Winnett ACES, Inc., \$10,000:** Funding was awarded for the Odd Fellows Hall Revitalization that will include moving and stabilizing the historic building in Winnett, then an exterior rehabilitation. Chris King, Diana Brady and Laura Kiehl told the audience at CMF's Annual Meeting about this and other projects Winnett ACES is working on to breathe new life into the community.

2020 Highlights

CMF President Dean Comes, CMF Executive Director Carrie Mantooth and Certified Public Accountant Stacie Arntzen gave reports on 2020 activities and highlights at the Annual Meeting.

CMF is the umbrella 501(c)(3) that holds pass through accounts and permanent endowments for local not-for-profit and tax-exempt organizations. By the end of 2020, CMF's unrestricted assets combined with the pass through and permanent accounts held for other organizations totaled \$29,518,242.61.

Contributions to the more than 200 funds held with CMF totaled \$1,575,800 in 2020. This total included all contributions and bequests to CMF's unrestricted funds, permanent endowment and pass through accounts for tax-exempt and not-for-profit organizations, scholarship funds and Donor Advised Funds held with CMF.

CMF has 10 unrestricted endowments, which are used for its grant program. The principal remains intact and only the dividends and income spent. In 2020, CMF approved grant requests at its monthly meetings totaling nearly \$230,000, including grants from the COVID-19 Relief Fund established in April

2020.

The Foundation has more than 50 active scholarship endowments and in 2020, nearly \$250,000 in scholarships were awarded to Central Montana graduating seniors and post-high school graduates. Total grants and scholarships from all CMF funds (unrestricted and restricted) totaled \$2,158,000 in 2020; that's \$450,000 more than in 2019!

CMF President Dean Comes reminded those in attendance that all CMF grant awards and administrative expenses are paid from earnings on the 10 unrestricted permanent endowments. "I want to emphasize that the Foundation loves being able to grant funds to improve life in our area, and we're pleased to help build capacity for other non-profits by managing their permanent endowment and pass through accounts," Dean said. "However, we simply must get our message out to donors that Central Montana Foundation must continue to grow its unrestricted funds if we want to increase our grant-making program to help community projects!"

Mickey McMillan honored as Friend of the Foundation

Central Montana Foundation (CMF) Board of Directors selected its long-time Certified Public Accountant Mickey McMillan as this year's Friend of the Foundation recipient.

CMF President Dean Comes presented the award at the organization's Annual Meeting at the Elks on May 25.

Before revealing her identity, Dean gave a few "fun facts" about the recipient. He said, "She has the need for speed – her vehicle of choice is her SRT Dodge Challenger that has a really big 470 HP engine. She's proven that by reaching 107 mph on the quarter mile track! She and her husband enjoy off-trail

adventures in their Razer and he said she always wants to drive. She went parasailing last year, but found it to be a bit boring. Skydiving would be more her style. During her college years she was a state champion blue belt in Tae Kwon Do, kata style."

Dean said Mickey has achieved great success in both her personal and her professional life. She spent 38 years working in accounting, with 37 of those years at what is now Huffine McMillan Arntzen & Ruckman. The Foundation hired Mickey McMillan with Schell Stephens Huffine Riley & McMillan in August 2003 to provide accounting services following the death of the Foundation's long-time CPA Don Romo earlier that year. "I came on the Foundation board that same year, so I can attest that Mickey and her staff have provided accurate and complete financials month and after month and year after year and it's always with a cheerful attitude and smile," Dean said. "She's gone above and beyond in her work for the Foundation; staying up-to-date to changes in tax laws that could affect charitable giving, and seeking out education for herself and staff about planned giving and other opportunities."

Mickey Hansen was born in Lewistown but moved with her family to the family homestead in Joliet when she was a young child. She graduated from Joliet High School in 1967, then earned a degree in education in 1971 from Eastern Montana College. She went back to college to earn her bachelor's in Business Administration with an accounting emphasis in 1983. She worked one year for an accounting firm in Billings before joining the Lewistown firm where she spent most of her career.

Fred Schell was one of the four men who were partners at her new firm and he recalls that from the start, Mickey was an outstanding worker. In 1984, women accountants were a rarity, but it didn't take long for the partners to realize that Mickey was willing and able to put in long hours and never complained. She passed her CPA exam in 1986

and was promoted to partner in 1999. Mickey continues to work part-time to help her long-term clients, but bumps her hours up to full-time during tax season.

Dale Huffine also has high praise for Mickey and said, "I could not have had a more loyal and hard-working partner in all my life."

The move to Lewistown was initiated when Mickey's husband, Lynn, took a teaching and coaching job at Fergus High School. The pair met at a track meet when they were in high school, reconnected at college and married in 1971. They celebrated their 50th anniversary May 29. a doctor, lawyer and an engineer." They also have six grandchildren who they love spending time with.

"CMF Board of Directors and staff are appreciative of the years that Mickey devoted to helping us succeed," Dean said. "She truly has been a great Friend of the Foundation and very deserving of this prestigious award." ❖

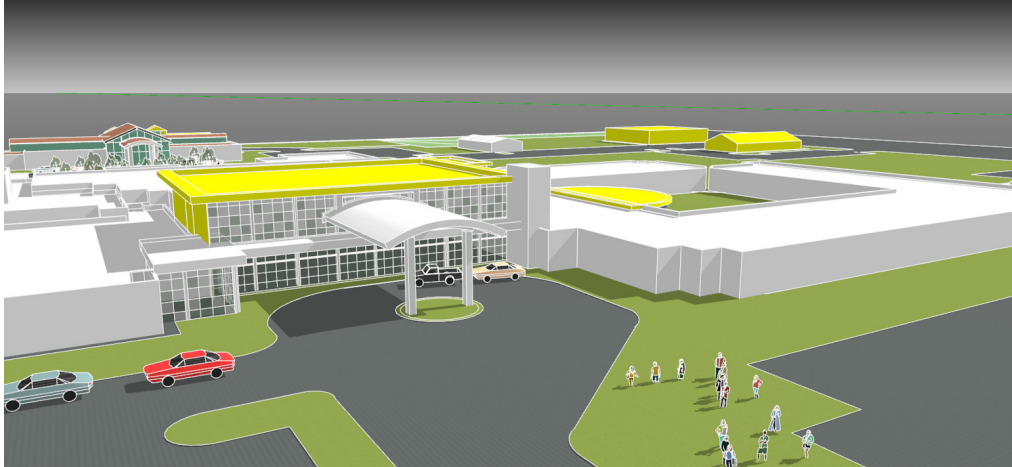
\$6M Helmsley Charitable Trust grant helping CMMC add cancer center

A \$6 million grant from The Leona M. and Harry B. Helmsley Charitable Trust is helping Central Montana Medical Center (CMMC) add a comprehensive cancer center, filling a huge coverage gap across nine rural counties in central Montana.

The \$8.9 million project in Lewistown, Montana will provide

high-quality cancer care closer to home for nearly 50,000 central Montana residents. The CMMC cancer center will help relieve the stress and burden of patients and families who currently travel up to 220 miles, sometimes five days a week, to Great Falls or Billings for diagnoses, radiation treatments and other services.

"The Helmsley Charitable Trust has made a distinct commitment to strengthen health care in rural locations, and access to cancer care services is a well-documented need in the Lewistown area," said Walter

Panzirer, a Helmsley Trustee. "We know how important it is to receive great care close to home where family and friends can provide much needed support. We are excited to see this project take shape."

CMMC plans to add a full-time oncologist in partnership with Billings Clinic Cancer Center, a

part-time radiation oncologist and a linear accelerator machine. The center will contribute \$1.9 million to the project, and the CMMC Foundation plans to raise \$1 million through a community capital campaign.

"I appreciate the CMMC Foundation's great success of the 3D Mammography capital campaign," said Cody Langbehn, Central Montana Medical Center's CEO. "The Cancer Center fundraising will dovetail in nicely."

CMMC plans to break ground on the center in the spring of 2022 with a goal of opening by the summer of 2023. ❖

Dr. Joan “Missy” McMahon honors family traditions

Charitable giving is a family trait that Joan “Missy” Marie McMahon learned early on from her parents, John and Joan McMahon. “It was a foundation in my family upbringing,” she said. “It was basically ingrained in me and all of my siblings by my parents. You give back to support those in need.” This included individuals and organizations including the church. Time and service are as important, if not more important as financial giving.

It was a lesson that Missy took to heart and she recalls that as a child, she learned to save a portion of her allowance and devoted 10 percent to donations. She recalls that many times her parents would see families in need and buy groceries or provide other anonymous gifts. “As I look back now, those are the most important things they taught us.”

Missy was raised in Helena and was one of 10 children. Her parents also adopted another sister and brother and fostered four others long-term and many others for short stints. Her father, Dr. John McMahon, died in 2015, and Missy lost her namesake and mother, Joan, in December 2020. Dr. Jack McMahon had a 31-year career in medicine, and Missy followed in his footsteps both as a physician, and as a graduate of St. Louis University Medical School. She did her undergrad studies at Carroll College with an initial degree in accounting and Business in 1981. She went back to school and earned her medical degree in St. Louis in 1996.

Missy went to work at Central Montana Medical Center in 2000 as an internist and pediatrician and also worked as an ER and primary physician while on staff. A few years ago she became a provider at Wheatland Me-

morial Healthcare in Harlowton, working in administration, patient care and the ER.

“Central Montana is such a great place,” Missy said. She talked about the beauty of the area with the valley and surrounding mountains, but what she loves the most are the people. “People here are wonderful and so giving of their time and truly do support one another.”

Missy has been quietly and regularly giving to a growing list of non-profits with funds held at Central Montana Foundation (CMF) for many years now. From healthcare and youth programs, to organizations helping low income individuals of all ages, Missy finds great satisfaction in doing what she can to help those

in need. An example of a way Missy recently found an opportunity to give was when she unexpectedly received payment from an unpaid patient bill from over a decade ago. The patient was struggling as a single mom when she incurred the debt, but since she was in a better financial position now, wanted to clear it. Missy paid it forward by passing it on to Central Montana Youth Mentoring Program as a tribute to the patient.

She emphasized the importance of modeling generosity to the younger generation, whether it be of financial resources or giving of one’s time. “It’s very rewarding personally to be able to assist someone in any way,” Missy said, proving the truth of the adage, “It’s more blessed to give than to receive.”

Missy said being able to write one check to CMF for multiple non-profits with funds held there is a convenience she appreciates. See Page 15 for the list of funds held at CMF or call 406.538.6130 for more information about giving. ❖

Medical Center Foundation grants funds for local projects

Medical Center Foundation (MCF) Advisory Board recommended the following grants for approval at its recent meeting:

- **Lewistown Park and Recreation:** a \$2,500 grant was awarded for an AED that will be on site at the Lewistown City Pool during the summer, and then available at the Civic Center.

- **Women Lead Central Montana (WLCM):** \$2,500 was gifted to WLCM to provide professional development in areas of leadership by encouraging women to come together for networking, inspiration, education, and personal and professional growth.

- **CMMC EMS:** MCF awarded a \$1,000 grant for an audio visual TV Monitor for EMS training purposes held at the ambulance bay, which will include remote teaching to rural EMS volunteers via telemedicine.

- **CMMC Hospice:** A grant of \$3,892 was given to CMMC Home Health/Hospice for a Broda wheelchair that has a full tilt-in-space and reclines 90 degrees for therapeutic pressure relief, aiding in the treatment of conditions of pressure ulcers, edema and postural deviations.

“The purchase of this very specialized wheelchair will offer Hospice patients in our community the needed comfort, and therapeutic pressure relief, not available with the standard wheelchair, which is so often needed with end of life care and comfort, said CMMC Home Health/Hospice Manager Kathy Ward.

Dave & Donna Byerly establish Donor Advised Fund with CMF

Central Montana Foundation (CMF) began offering its donors an option to establish Donor Advised Funds (DAFs) a few years ago and according to CMF Executive Director Carrie Mantooth, Dave and Donna Byerly were catalysts for that change.

"I'd seen a few checks come in from the Byerly's DAF that they held with another charity and that sparked my interest," Carrie explained. She visited with the couple and asked Dave to share their experience with DAFs at a CMF Board of Directors meeting. CMF Directors decided to add this type of fund to its portfolio as another tool for philanthropic giving.

Dave explained why a DAF has worked well for them: "We had some investments which had appreciated over many years, and we had a desire to do more to support our church and community. Our financial advisor suggested a Donor Advised Fund, which allowed us to avoid taxes on appreciated assets while improving our ability to give to causes we wanted to support. It made sense to us and worked just the way we had hoped."

The Byerlys established a DAF with CMF late in 2020. "We have a lot of faith and trust in the Central Montana Foundation and the people who oversee and manage it," Donna

said. "We were thrilled when a Donor Advised Fund became an option to us through our local foundation."

Dave said he remembers when CMF was founded in 1984 and said, "It's been truly amazing to watch how people in this area supported and grew its assets, how they continue to donate to important causes through it, and the vital community projects it has made possible. The Central Montana Foundation has been well managed and has become part of the fabric of our area. And it allows those who want to give back to their community to do so in a variety of ways with the best possible tax benefits."

The Byerlys are long-time residents of Lewistown and ardent supporters of Central Montana. Dave was born in Lewistown and raised in North Carolina.

He returned to Lewistown in 1977, after earning a degree from the University of Colorado and serving three years in the Army, where he and his father, Ken, owned and operated the Lewistown News-Argus. After selling the newspaper in 2000, he worked at Sports, Inc. in Lewistown.

A native of Bozeman and graduate of Montana State University, Donna moved to Lewistown in 1979 to work as a medical technologist (Clinical Laboratory Scientist) at Central Montana Medical Center. She retired in 2010.

Together, the couple raised three children in Central Montana and today are active in their church and community activities.

In the event of their death, whatever assets remain in the Byerly's DAF stay with CMF to benefit the community. Dave added, "We prefer the minimal expenses we pay for the substantial benefits of a DAF that stay with our foundation rather than an entity with no interest in Central Montana."

The Byerlys said setting up the DAF at CMF was easy. "Your accountant or financial advisor can explain the benefits, and the Foundation makes it simple," Dave said.

Donor Advised Funds (DAFs) have become a popular philanthropic tool where a donor(s) establishes an account with a public charity like Central Montana Foundation. Benefits include:

- The donor receives a tax deduction in the year the DAF is funded. For endowed DAFs, the donor can recommend grants from the contributions and investment gains to his or her choice of recipients over as long of period as desired. For non-endowed funds, the donor can make recommendations for grants until the balance is spent. Grants must be to qualified tax-exempt or non-profits in the United States.
- If the donor gifts appreciated assets such as securities and real estate, they may avoid capital gains on the appreciation.
- There's no tax on the fund's growth, providing a low-fee alternative to setting up their own foundation. Learn more by calling CMF at 406.538.6130!

CMF awards nearly \$20,000 in minor grants over last quarter

Central Montana Foundation (CMF) Board of Directors has awarded nearly \$20,000 in minor grants (those under \$5,000) at its monthly meetings over the last quarter to a variety of projects benefiting the young, the old and in-between!

Congratulations to the following organizations receiving grants:

- **Heath Rural Fire District** : This organization received \$4,900 to help with the installation of a new heating system at the Heath Community Hall. The Heath Rural Fire District took over the hall and uses it for firefighter training, online training, board meetings and other community events.

- **Tri-County Crisis Intervention Stress Management Team (CISM)**: A grant of \$1,500 was awarded to help this organization with debriefing expenses. Volunteers with special skills, training, and interests respond to help their peers deal with the stress resulting from crisis situations.

- **Unreserved**: A \$3,180 grant was awarded to Unreserved to help with expenses for Fergus High School teachers and students to attend a conference at Big Sky June 15-16. The Unreserved Project strengthens social structures in schools through an art project incorporating four themes (heritage, hurdles, happiness and hope) and through a humanities program with community and professional leaders sharing their stories, according to its organizer, Dani Phillips.

- **SMDC-WOMEN LEAD**: CMF Directors granted \$2,500 to help with this year's Women Lead conference expenses. The event is organized under the sponsorship of Snowy Mountain Development Corporation (SMDC) to provide professional development in areas of leadership for women. This is the fourth year for Women Lead and this year, they will hold two events, the first on June 10 conference and one in the fall, according to one of its founders and organizers, KellyAnne Terry.

- **Stanford Youth Baseball**: A grant for \$3,193 will help purchase a pre-made concession booth for home baseball games. Volunteers with

Both permanent endowment and pass through accounts require a \$2,500 minimum to open the account.

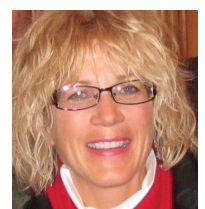
