

CMMC plans launch of Cancer Center Capital Campaign in early 2022!

The last year has been a traumatic one for breast cancer survivor Derree Kamp, but she's finding a great deal to be thankful for as we near the end of 2021. Near the top of her praise list is the news that a cancer center will be built at Central Montana Medical Center (CMMC).

"Our community desperately needs it," Derree said. As a new member of the CMMC Foundation Advisory Board, she will be helping with fund-raising efforts once a capital campaign is launched in early 2022. "I'm 100 percent committed and excited to help!"

Derree learned she had breast cancer right after Christmas last year. She described the series of events that had led her to get a mammogram scheduled at CMMC in early December.

She has a family history of cancer - her mother died of uterine cancer a few years ago, and an older sister had previously battled breast cancer. When her younger sister was diagnosed with breast cancer last November, Derree knew it was time to take action.

doing those out of town. Since CMMC had recently acquired the 3D Mammography and breast biopsy equipment, she made the decision to schedule her mammogram in her hometown and is glad she did.

The mammogram revealed a suspicious spot and she went back for an ultrasound and then a biopsy. CMMC Oncology Nurse Navigator and Cancer Care Services Coordinator Amy d'Autremont worked with Derree once she was diagnosed to guide her through the treatment and recovery process.

"Amy has been amazing!" Derree said. Amy's role is to be the "hub of the wheel" to work with the patient and keep all the multidisciplinary people up-to-date and current with the patient's cancer care. She eases the stress for the patient and their families as they navigate these unfamiliar and turbulent waters of a cancer diagnosis.

For Derree, it meant working with Billings Clinic surgeons for tandem bilateral mastectomy and reconstruction surgeries, and a sen-

The News-Argus is one of the longest running businesses in the area, with its roots going back to 1883 when it was the Mineral Argus published in the bustling gold-mining town of Maiden. Name changes and consolidations saw the newspaper evolve through the years. According to Jacques, the most important change for the newspaper occurred in 1972 when owner and publisher Ken Byerly wisely made the decision to switch from the Daily News - which covered national and state news - to the Lewistown News-Argus, with the focus on local news. With a new motto, "Covering Central Montana like the stars," going to a twice weekly newspaper provided readers with community news that they

couldn't get anywhere else.

The Lewistown News-Argus is part of the Yellowstone Newspaper Group, made up of 13 small community newspapers. Jacques was hired by former owner, Dave Byerly, as a sports reporter for the Lewistown paper in 1997. He branched into news reporting, then managing editor, before being promoted to publisher in 2009. He's also publisher of the Judith Basin Press in Stanford.

He said a major change has been going digital and having an online presence. "It's really transformed the whole industry. One of the best things is that people who might not want to get the paper are able to read it on their phone or computers from anywhere," Jacques said, adding that people with ties to Central Montana appreciate being able to keep tabs on the area.

Jacques is proud that the newspaper and print shop have a number of long-time employees. As a case in point, print shop manager Tim Hartford began work there in 1981. Jacques said everyone in the print shop has 20+ years' experience in the printing business.

Many of the News-Argus staff members are invested in the community beyond the work place and Jacques said that kind of attitude and volunteerism is what sets Central Montana apart.

"The great thing about living here is that everybody pulls together and gets things done; from supporting medical needs to hockey rinks and soccer fields." He added, "I really appreciate the Foundation's role in helping those efforts. It's amazing what the Foundation and this community have been able to accomplish."


George Mueller just keeps on giving; even after his death!

Central Montana lost a good friend and local historian when George Mueller died on on October 15, 2016, at the age of 94. He was generous during his life, and provided legacy gifts totaling about a quarter of a million dollars to a number of local organizations upon his passing.

Recently, three local organizations were surprised to hear that they were the recipients of another unexpected gift from George's estate as a result of a settlement from a class action lawsuit. (No details were provided regarding the

George enjoyed local and state history and his articles appeared in the Montana Magazine of Western History and the Lewistown News-Argus. Carrie added, "I hope that George's record of contributions to the commu-

nity he loved will always be preserved in our history."

tinel node biopsy by CMMC Surgeon Dr. Scott Smith. This was followed by radiation, for four weeks in Billings. Derree said she had family in Billings to stay with, but stressed that the best alternative would have been to have that treatment close to home and sleep in her own bed every night. "I can't imagine what it's like for some people to have to travel and who can't stay with family members. I'm so excited about the conveniences this cancer center will afford for so many people.""

Amy is also a new member of the CMMC Foundation Advisory Board and excited to be involved both professionally and as a volunteer in seeing the cancer center dream become a reality. "A cancer center will improve both the patient and family's quality of life," she said.

A comprehensive cancer center at CMMC will bridge a huge coverage gap across Central Montana where patients are currently traveling up to 220 miles for diagnoses, radiation treatment and other services.

"I never thought this would happen," Amy said of the opportunity to build a cancer center at CMMC. "We will have such an amazing resource that will serve our community for years to come. I'm very passionate about it!"

The catalyst to move forward with plans for a cancer center at CMMC was a \$6 million grant from the Leona M. and Harry B. Helmsley Charitable Trust announced over the summer. The project plans will be finalized in the coming months, but initial estimates are that it will be about a \$8.9 million project and CMMC Foundation will spearhead a \$1 million capital campaign for the center.

CMMC Foundation Director Abby Franks started her new position at CMMC in October. She has hit the ground running and looking forward to the launch of the Cancer Center campaign.



Long-forgotten debt results in donation to CMMC Foundation

There are some stories that are too good not to share, and this is one of them.

In 1947, Dr. Paul Gans delivered a baby boy born in Lewistown at the old St. Joseph Hospital; his father and mother named him Bill. After moving from the area and while living in Wyoming Bill's parents were told that their 3-year-old son wouldn't live to see his sixth birthday. Bill had a rare genetic kidney disorder and the news devastated the family. They left a thrivwould be better for their son.

Once again, while living in the Hobson area, Dr. Gans treated the youngster. His family credits this well-known family physician for ten 52 years ago to repay a debt forgiven nearly 70 years ago. helping extend his life.

The family stayed in Central Montana for only a short time before once again moving on. Doctors from the Mayo Clinic cared for the youngster while the family lived around Billings. Even though he was never cured, he did in fact make it past his sixth birthday and died at the age of 21 at the Stanford University Medical Research Hospital in 1968.

Bill's mother had written a letter to her sister in 1969 detailing all the hospitals and doctors that needed to be paid following his death.

Years passed...decades passed, when one of the family members recently came across that letter and realized there was a debt that had never been paid to a smalltown physician in Lewistown - Dr. Paul Gans.

The letter said they owed Dr. Gans about \$60. Dr. Gans had long since retired and had died in 1991, as Bill's family member soon discovered. Bill's parents were also

However, they tracked down Dr. Gans family and sent a letter and check for the debt multiplied by five. "I feel certain that you and your family do not actually need the money; however, my family does need to pay it," was the explanation. The Gans children decided to give the money to Central Montana Medical Center Foun-

Dr. Gans arrived in Lewistown in about 1937 and retired in 1979. He and his wife, Isabel raised five children. Their only son, Dave Gans, lives in Helena and communicated with the family about the surprise gift stemming from that long-ago debt.

He recalls that in the early years of his father's practice, medical insurance wasn't as prevalent and "bills were probably forgiven more often


Dave said he and his siblings were amazed that Bill's family member took the initiative to honor their mother's wishes as outlined in that letter writ-

Betti Foundation provides additional \$1.4 million for PCCC

The Bruno and Evelyne Betti Foundation honors its namesakes by continuing their life's mission of helping youth and community.

That razor-sharp focus was demonstrated with the Betti Foundation's gift of \$1.6 million earlier this year to the Petroleum County Community Center (PCCC) Youth Program, followed up with a surprise gift of a \$1.4 million endowment for PCCC set up with Central Montana Foundation.

Stanley Hill is president of the Winnett. Betti Foundation and one of its

three directors, all of whom knew the Bettis well. Stan's ties are particularly close, as Evelyne (Hill) Betti was his aunt and they shared a deep appreciation for their experiences growing up in Petroleum County. Stan is a 1963 graduate of Winnett High School (WHS). Evelyne was raised on a ranch northwest of Sand Springs and graduated from WHS in 1936 before moving to Seattle. "Evelyne never forgot where she came from," Stan said, adding, "It is a blessing in life to never forget your roots."

Evelyn married Bruno Betti in 1941 and together they successfully built several businesses including a business park in

the Lacey, Washington area. The Bettis were committed to helping others, and one way of doing that was to charge below market rents as a means of helping small business tenants grow and become profitable. "Giving a Leg Up" so others could succeed was important to Bruno and Evelyne and is the heart of the Betti Foundation's mission.

The Betti Foundation was founded in 2009 and is guided by goals centered upon providing support for vocational programs, helping new businesses and craftsmen, promoting

technical and professional skills to lead young people into a career, helping underprivileged populations achieve life goals and helping provide opportunities that otherwise wouldn't be available in smaller communities. "What the Betti Foundation has supported in Winnett really speaks to what we are about; it's directed at youth and it's directed at community, 'Giving a Leg Up," explained Stan.

Gift to Saving Animals From Euthanasia is first step towards animal shelter

A very generous gift to Saving Animals From Euthanasia (SAFE) is the catalyst towards building an animal shelter in Lewistown.

Jeanne Moe recently gifted stock to SAFE's fund with Central Montana Foundation (CMF) with the caveat that it is to be used towards the purchase of land where an animal shelter will be built. SAFE will close in early December on an acre and a half plot in a commercially-zoned subdivision a few miles north of Lewistown.

"We are so grateful to Jeanne for giving us the opportunity to have a facility in this town," said SAFE's Director Peggy Butler. "It's sorely needed!"

She explained that Lewistown has a city-owned ics over the past few years. animal pound - where stray animals are impound-

ed - but not an animal shelter, where the public has opportunity to come in and adopt animals. "It's very unusual for a town this size to not have an animal shelter," Peggy said.

SAFE is working out plans for its animal shelter, which will include plenty of room to segregate and care for animals and an outdoor area for exercise.

Jeanne, a self-described animal lover, imagined a life on a ranch, until she learned that she could be an archaeologist as an undergraduate at Montana State University. She went on to earn master's degrees in archaeology and education and a doctoral degree in science education. In 2019, she retired from the Bureau of Land Management where she worked in archaeology and education for 32 years. Jeanne plans to return to Lewistown full-time to reconnect with the land and animals always so important to her. She maintains homes in Bozeman and Lewistown, but is making plans to live full-time in Lewistown. "I'm coming full circle back to the land and animals," she said.



Jeanne attended a SAFE fund-raiser a few years ago and was impressed with its animal welfare mission and wanted to help. Besides the financial assistance, she has fostered kittens and has frequently transported animals to Heart of the Valley shelter in Bozeman, which she calls the "crown jewel" of animal shelters.

"Lewistown does have an animal shelter and it's Peggy's house," joked Jeanne, adding that she calls her "Saint Peg" for "going above and beyond the call of duty" in providing compassionate care to animals.

A main mission of SAFE is sponsoring cat spay and SAFE has organized a number of spay and neuter clin- neuter clinics. CMF Board of Directors recently granted \$4,999 (see related story below) to assist SAFE in conducting four clinics over the course of the next

> year. Peggy looks forward to someday holding these clinics in their own facility. She also voiced her appreciation that Jeanne is a valued volunteer at the clinics and at SAFE's fund-raiser in June.

> For Jeanne, it's a labor of love. "Animals are so therapeutic, and having an animal shelter helps a community in many ways." Among the benefits she listed were companionship, reducing the unwanted animal population through spaying and neutering, animal health education and improving pet health, and providing animal lovers a place to volunteer.

> Peggy said SAFE is in the investigative stages of building the shelter, and will need to develop plans before launching a capital campaign. "We are looking forward to starting the fund-raising process to get this facility up and running as quickly as we can." CMF awards another \$10,000+ in grants at its fall meetings

Central Montana Foundation (CMF) Board of Directors has awarded more than \$10,000 to several non-profit causes in Central Montana at the September and October meetings

Congratulations to the following grant recipients:

• Garfield Elementary's Harvest of the **Month:** A grant of \$345.84 was awarded for this program for around 175 kindergarten and first graders. The Harvest of the Month focuses on one locally-grown item and includes a quick snack of the food, lesson and activity.

· Lewistown Junior Rifle Club: A grant of \$4,999 was awarded for the purchase of two grant. rifles with sights and slings and seven shoot-

ing coats. Erik Brandt has been a volunteer with the Rifle Club for 19 years and took over as director following the death of Jo Shipman nearly a year ago. He said the junior rifle program is for shooters ages 12-19 and they currently have 39 participants. They shoot .22 rifles at the range in the

basement of the Lewistown Civic Center. Their goal is to continue to upgrade their rifle inventory. "With new Anschutz rifles and shooting coats, the Lewistown Junior Rifle Club will be able to compete at the state shooting match this spring taking place here in Lewistown," Erik said.

· Saving Animals From Euthanasia: A grant of \$4,999 was awarded to help fund four spay/neuter clinics for cats over the course of the coming year. SAFE's Director Peggy Butler said they have been holding clinics over the last two years and have spayed or neutered 377 cats during that time. They target low income pet owners and hope to help them become responsible pet owners.

Rich & Donna Dengel establish Donor Advised Fund with CMF

Richard (Rich) and Donna Dengel set up a Donor Advised Fund (DAF) with Central Montana Foundation (CMF) earlier this year, and have used it to award scholarships for students pursuing a medical career and for other charitable causes.

The Dengels are long-time supporters of projects in Central Montana and decided that having a DAF could simplify their giving. "It's convenient for us and is working great," according to Rich.

CMF began offering DAFs a few years ago in order to provide another tool for philanthropic giving. Donors fund the DAF and receive a tax deduction for the gift in the year it was given. "Most of those donors who set up DAFs are giving primarily to local causes, but they can and do recommend grants outside of Central Montana," said CMF Executive Director Carrie Mantooth.

A main focus of the Dengel's DAF is on scholarships. They founded the Darcy Lynn Dengel Foundation in 2008 in their daughter's memory to help students who are pursuing a bachelor or master's degree in nursing. Darcy was a Mercy Flight Nurse who gave her life in service on Feb. 6, 2007. The information about the Darcy's Foundation sums up who she was: "She gave of herself for the benefit of others, not only to care for people using the tools of a competent and skilled nurse but to heal their spirits and souls as well."

Rich and Donna said they still hear stories about the impact Darcy had, and as an example shared a letter and photo they received with a donation for their Foundation in October from a cardiologist in Hawaii. In his letter to the Dengels,



Dr. Sekon Won said, "I met Darcy when I was rotating through Browning, MT hospital in 10/2001. Coming from Boston, I didn't know a soul in Browning, but Darcy was so gracious and kind to befriend me. As you well know, she was full of warmth and a generous spirit."

The scholarships through their private foundation are apart from the scholarships they are awarding through the Richard and Donna Dengel DAF. The couple explained that they felt compelled to help other students who are pursuing careers in the medical field, who may not be nursing students. Their Foundation's scholarship cycle also didn't match up with

The Dengel's DAF has provided more than \$20,000 in scholarships to 13 students this year. In addition,

they have recommended grants to several other charitable causes.

The Dengels are firm believers in helping community and giving of time and resources. Donna is reticent about her contributions, but she is an active volunteer for Central Montana Community Cupboard, Lewistown Library, Compassionate Friends and Tri-County CISM. The couple are also ardent supporters of many projects at Central Montana Medical Center (CMMC), particularly for training of First Responders. Donna previously served on EMS crews in Three Forks and at CMMC, and recognizes the importance of training.

Rich and Donna said they find great satisfaction in being able to help others. "It's important that we all do our part. Central Montanans are very giving - neighbors helping neighbors is part of our culture," Rich said.

course of the next year in large part thanks to the assistance from another Winnett native, Larry Carrell, as well as the generosity of other donors and grants. Stan also has high praise in general for the PCCC Board of Directors. "I've been to Winnett quite a few times over the last 18 months. When I met with this committee for the first time, I immediately realized that they are a special group. They have a lot of talent, a lot of connections and a dream for their community. Coming from a county with just 500 people, to have a group of ladies with this level of expertise is incredible!"

PCCC Board members are still in a state of euphoria over the outpouring of generosity to make this dream come true. "It's not just by blessing us with financial gifts, but with unending support, sage advice, and honest feedback," Brandi Lang said of the Betti Foundation gifts and the support offered by Stan.

Sue McKenna of the PCCC Board said, "The generous donation just rein-

forced the fact that everyone wants to see Winnett have a beautiful facility and be a success for generations to come. When you are from Winnett, there is a sense of hometown pride even if you no longer live here."

Stan said he and the other directors of the Betti Foundation maintain a commitment to presenting and preserving the legacy of Evelyne and Bruno. "They didn't have any children, and their entire focus was 'Giving a Leg Up' to help kids and community to become better citizens."

Marilyn Moore's savings bonds added to estate gifts

In the last issue of *The Roundur*, an estate gift totaling nearly \$800,000 from the Marilyn Moore Trust was announced, which provided for a scholarship fund for Winifred students, and gifts to Winifred Methodist Church, Winifred Cemetery, Central Montana Medical Center's Cancer Center project, Council on Aging and Lewistown Public Library.

The trust was from the combined assets of Margaret, Marilyn and Orpha Moore, who were raised on a ranch near Winifred. The sisters never married and had lived out their lives on the ranch before moving to Lewistown in later years.

The estate's personal representative Jodi Ruckman recently found some savings bonds that Marilyn Moore had "tucked away," and said they will add about \$115,000 more to the estate's distributions!

Jodi grew up in Central Montana and recalls seeing Marilyn and her sisters, Margaret and Orpha. "They always dressed in their skirts, scarves, flipup sunglasses, and sometimes their rubber pull-on over boots, driving their

blue Ford pickup." The sisters were private and quiet, but Jodi said, "you couldn't forget those ladies!"

Fast-forward 30-years, and Jodi began working with Marilyn through her work as a CPA with Huffine McMillan Arntzen & Ruckman. She stressed that the Moore sisters led a very private and frugal lifestyle.

"I had the pleasure of working with Marilyn for only a short time, preparing her taxes and helping with estate planning. We visited about the passions that she and her sisters had growing up and she was happy to leave her estate to those organizations that have touched their lives in one way or another."

Jodi said Marilyn didn't realize just how large her estate was, "and frankly, neither did I!" Jodi believes the Moore sisters would enjoy knowing that their lifetime of frugality will provide such positive impacts in Winifred and the Central Montana area. "The Moore sisters definitely have left a legacy and we should be forever grateful," Jodi said.

CMF's planned giving program qualifies donors for MT tax credit

Central Montana Foundation (CMF) has been intentionally building its planned giving program in recent years.

Donors have appreciated being able to take the Montana Endowment Tax Credit by setting up a planned gift that will ultimately benefit a qualified endowment. The tax credit was established to encourage individuals, businesses and organizations to make lasting investments in their communities by giving to qualified endowments like those held with CMF.

CMF invested in software a few years ago that creates professional illustrations for donors who are considering setting up a charitable gift annuity. "Once we gather the relevant information, we can present information back to the donor that provides a close approximation of their federal charitable tax deduction and Montana Income Tax Credit," according to CMF Executive Director Carrie Mantooth.

"Most of the planned gifts we've set up have been deferred charitable gift annuities as a means for the donor to reduce a tax liability from a sale of a business or ranch," Carrie said. "It's been very satisfying to these donors to realize they can reduce that tax bill by helping charitable causes."

Another popular planned giving tool is a charitable gift annuity, where the donor can take income before the asset is gifted to charity.

Carrie works closely on the planned giving program with Stacie Arntzen, a CPA with Huffine McMillan Arntzen & Ruckman, the firm which provides accounting services for CMF.

Planned gifts are a way of giving that allows donors to maintain access to income during their lifetime, provide estate and tax planning tools, and build permanent wealth for Montana's charities like those in the long list of endowment funds held under CMF's umbrella (see page 15.)

The incentive is 40 percent of the gift's federal charitable deduction, up to a \$10,000 per taxpayer or \$20,000 for joint filers, and a credit of 20 percent of a direct gift by a qualified business, up to \$10,000 per year. This is a direct deduction of the Montana income tax liability!


